# YOUTH DIVISION JURIED ART SHOW

(for students ages K - 12th grade)

## RULES

The objective of the Youth Division Juried Art Show of the 60th DeLand Outdoor Art Festival is to encourage the community's young people in their creative pursuits. However, prize money is at stake and we ask the cooperation of the young artists and their parents in following the rules set forth below. We want the Youth Division Juried Art Show to be a positive learning experience for all and a fair competition for all the artists who enter — fair and fun. Thank you.

1. Youth Division Juried Art Show registration, completed in full, must be received by Wednesday, March 26, 2025. Students whose registration form is late may exhibit their work, but their artwork may not be considered for judging.
2. Email registration form to **creativeyoungminds18@gmail.com**, or drop off or mail to:  
**The West Volusia Beacon Newspaper**  
110 W. New York Ave., DeLand, FL 32720.
3. Students may enter up to two pieces and these pieces may be created in one or more mediums. All artwork must be original. There is no fee to enter the Youth Division Juried Art Show. Students are permitted to bring other artwork in addition, but they will not be part of the judging.
4. Students are allowed to sell their artwork during the art show.
5. Students are responsible for their own displays. A display may be as simple as a folding table, or a simple easel. Artwork need not be framed or mounted, but the festival is outdoors, so artwork may need to be protected from blowing away. Be prepared for sun, wind or rain.
6. All student exhibits must be fully set up by 9:45 am and students must stay with their artwork from 10 am – 2 pm. Judging is from 10 – 11:30 am and award presentation is at 1:30 pm.
7. All artwork must be removed by 3 pm Saturday, March 29, 2025. All artwork not claimed at this time will be collect and it's the artist's responsibility to claim within 10 days.
8. Parent or guardian will need to be present with the student at all times. The parent or guardian who signs the front of this form agrees to provide supervision for children who are not old enough or responsible enough to remain unsupervised at the Art Festival.
9. We reserve the right to assign appropriate space at the Youth Division Juried Art Show to each exhibitor.
10. We reserve the right to reorganize the Youth Division Juried Art Show age categories if not enough entries are received in any category.
11. Pets will not be allowed in the Youth Division Juried Art Show area.
12. The parking lot in front of the Youth Division Juried Art Show area closes promptly at 9 am. You may unload your artwork prior to 9 am and then park elsewhere.
13. Neither The West Volusia Beacon Newspaper nor the DeLand Outdoor Art Festival Inc. assumes any responsibility or liability for the safe return of artwork entered in the Youth Division Juried Art Show.
