

The 61st Annual DeLand Outdoor Art Festival 2026 Rules

Saturday, March 28th, 2026 - 9 am to 5 pm Sunday, March 29, 2026 10 am to 4 pm

RULES APPLY TO BOTH JURIED AND CRAFT (Non-Juried) SECTIONS (No Buy/Sell Products or Productions)

Please read carefully and retain for your reference

- 1. We do not accept buy/sell products or productions. ONLY artist and craftsmen displaying their own ORIGINAL work may participate. NO SUBSTITUTE EXHIBITORS will be permitted**
- 2. Only one artist will be permitted to exhibit in each space. A two - person team or partnership may qualify as a single exhibitor if this is adequately explained in the application.;**
- 3. Accepted artist must be present and remain at the festival both days to be eligible for show rewards.**
- 4. Booth sizes are 12' X 12'. Artists must provide their own canopy, sturdy display and anchors no less than 40lbs. for each leg and tie downs. Be prepared for sun, wind and rain. No electricity is available**
- 5. Deadline for receipt of entries is March 15, 2026 or when foil. All exhibitors must check in at registration located at the Wayne Sanborn Activity Ctr. 815 S. Alabama Ave. DeLand, to obtain their booth space before ever setting up their exhibit.**
- 6. NO REFUNDS FOR CANCELLATIONS.**
- 7. Name, hometown, medium and space number must be displayed prominently on the artists/craftsman information card provided by the committee.**
- 8. INELIGIBLE for JURIED section: work from commercial patterns, knitting, crochet, ceramics cast from commercial molds, coins or fork/spoon jewelry, art supplies, velvet paintings, commercial picture frames, horticulture, scrap craft, kits, bread dough, novelties, decoupage and sunglasses.**
- 9. INELIGIBLE for CRAFT section: jewelry not made by craftsman, art supplies, velvet paintings, commercial picture frames, sunglasses, dealers imports and purchased items for resale.**
IB. Previously received awards or ribbons may not be displayed.
- 11. Artists are responsible for collecting and forwarding 6.5% Florida Sales Tax to the Department of Revenue,**
- 12. Ribbon Awards distributed at 4:00 pm Saturday. Cash Awards distributed at 3:00 pm Sunday at the amphitheater located by the lake.**
- 13. Artists and their families are ineligible for Spectator Award Drawings held every hour Saturday 10:00am to 4:00pm & Sunday 11:00am to 3:00pm**
- 14. Pets are allowed only if owners clean up after them and maintain control over them at all times.**
- 15. When any rules are violated, the Festival committee reserves the right to ask the artist or crafter to leave the show, or remove the offending or ineligible piece of work.**
- 16. Additional information concerning set-up procedures & directions will be sent to accepted artists.**
